DATA PROTECTION-RELATED INFORMATION FOR PERSONAL DATA

We, Steiner Kidsentertainment GmbH of Gewerbegebiet 13, 2100 Stetten, Austrian Register of Companies no. 446409i, must photograph your child at initial registration in order to ensure that we correctly identify your child, and to ensure that we always hand over your child to the correct person. The availability of said photo is thus a contractual requirement. The processing of this personal data is required to correctly perform the service of supervising your child at Kinderland Dachboden Zauber, and in accordance with GDPR Art. 6, paragraph 1 (b). The submission of this form signals your active consent to the processing of the photo and all health-related personal data provided by you, in accordance with GDPR Art. 6, paragraph 1 (b) in conjunction with Art. 9, paragraph 2 (a).

Furthermore, we process personal data in regard to postcode, day of visit, duration of visit, whether chaperone is a member of the Donau Zentrum loyalty programme, booking of birthday parties, and children's ages in order to generate fully anonymised statistics. These are subsequently transferred in anonymous form to DZ-Donauzentrum Besitz- und Vermietungs- GmbH (in accordance with GDPR Art. 6, paragraph 4 in conjunction with Art. 5, paragraph 1(b) as well as the Austrian Data Protection Act Paragraph 7, Section 1 Z 2).

Your personal data is transferred to our data processor, Jeff Webservices. No data is transmitted to third countries or international organisations.

We store your data for only as long as necessary. Personal data is automatically erased at the very latest upon the 13th birthday of your child.

Every data subject has the right to receive information from the data controller (see below) about what kinds of personal data are stored; about data access, rectification or erasure; may demand that processing be prohibited or restricted; and to be provided with the personal data held on the subject.
